### Minutes of meeting held on 27<sup>th</sup> January 2014 in Dores Parish Hall 7.30pm

#### 3. Adoption of Previous Minute (2<sup>nd</sup> November 2013):

Minutes approved with the following alteration/addition to item **8. Planning** – as regards the Local Dev Plan.

Comments( to be) submitted are as follows:

1) The area marked on the plan at DO1 are not congruent to the boundaries with adjoining ownership. The area is significantly different to that discussed by the Community Council and HSCHT for the development of housing. In addition this land is for mixed development of affordable housing with plots for self build.

Changes to the wording of section DO4: Uses: Community Use only as opposed to 'sports pitch'  
Remove the wording 'non-permanent changing facilities', replace with 'Any built development limited for community use'.

SSE Open Afternoon on 27<sup>th</sup> Nov attended by 5 members of public. CC have information for any more who wish to view it. Other sessions have also been held locally

Fish Farm – Meeting with Cllr M Davidson and Nicola Drummond 28<sup>th</sup> Jan. Request map to show place and time of cage movements proposed. John Macleod has sold fish farm.

Winter Resilience - Equipment not yet arrived – to chase **Action: RMacK**

Church of Scotland – Jeff Fridge (Cemetery Admin Office) keen to progress with graveyard expansion. Talk to Ward Manager, Charles Steven **Action: SH**

Roads and Signs – No progress on signs – some queries with Council are 4 years old. HC have staffing problems. Need to chase Richard Evans for plan to progress. **Action: SH**

Throw in buoys – No progress **Action: SF**

Safety Signs – now up

LEADER – Ongoing issues with 'in-kind'. CC noted that Dev Trust keen to recoup loan funds.

Bus shelter clearance– Community Services will assist

Aldourie Castle – Plans for access now submitted and seem to show high level of access

## 6. Treasurer's Report

Still need to sort new signatories. Register for online banking in May.

## 7. War Memorial

Roddy Ross and Donnie MacIntosh looking at installation for new war memorial – possibly at old petrol pumps. Current memorial (arch at Dores Parish Church) does not list WW2 and any subsequent names of those killed in action.

More research need into those names missing and some action to have them recognised during this year of remembrance. Also discuss options with Cllr M Davidson and Ward Manager. Stewart Wardlaw. (Roddy Ross)

Consider restoring existing memorial and adding names. Photos of original supplied by Iain Cameron.

Note that grants currently on offer are for restoration and not new memorials.

Any action would need to go to Old Parish of Dores for consultation.

## 8. Membership and Communication

Guidance from HC (as in Constitution) is that members must attend meetings regularly and may have to stand down in 3 or more consecutive meetings are missed.

SH would like to establish preferred methods of communication for each member to assist in attendance and action feedback for meetings.

CC agreed to fund new software to ease this for SH.

## 9. Planning and Development

Also road needs to be adopted as there are now 6 houses, 2 with 'granny annexes' (i.e.8 dwellings) plus one more house about to be built. Write to TEC services.

Letter to go to all Bike Hire companies to encourage use of cycle paths rather than main B862
