3. **Minutes of the last meeting** – accepted as a true record

4. **Matters arising from the minute of the last meeting**
  - a. Church of Scotland  
Cllr Davidson agreed to progress this on behalf of the CC
  - b. Etape Loch Ness  
Malcolm Sutherland & Morag returned to the meeting. Maps made available showing route (JH to put on website). Planned for 26/4/15. Approx 3,400 planning to take part (last year 1,200). Shortened lengths brought in to reduce road closure time. Local needs will be accommodated where possible, but people are asked to inform where these are required. Improved communication between event security and locals planned.  
Working with local tourist groups on community benefits. Striving for 100% local marshals on the road, at feeding stations, registration etc. Donations will be made to community groups/charities.  
Information leaflets to be delivered a few weeks before the event and via other media starting this month.

Safer route to school is along road where no pavement exists and on a 60mph blind bend. It was requested by a member of the public that the CC raises an objection with THC cc Holm CC
